RATES The rates shown are group rates and subject to change based on availability. Additional promotions may be available at the time of booking and will be applied if combinable with the group rate. Staterooms other than those listed may be available upon request. Staterooms that accommodate a 3rd and 4th passenger are based on availability and may require a different room category.

DEPOSITS The initial deposit due at the time of booking is 20% of cruise fare unless a reduced deposit promotion is available. The deposit is refundable until March 24, 2020. If you elect the Princess Vacation Protection and would like the cancellation coverage to begin immediately, the premium must be paid at the time of the deposit.

DEADLINES The group is holding a limited number of staterooms. All stateroom will be assigned on a first come first serve basis. Staterooms showing a "guarantee" category will be assigned closer to the sailing date. The cruise final payment is due to the agency no later than **March 24, 2020**.

PASSPORTS Guests are required to travel with a valid passport.

DINING TIMES The dining times will be assigned based on availability at the time of booking. The choices are: Early Dining at 5:00PM, Traditional at 7:15PM, or Anytime Dining 5:30PM to 10:00PM.

MEALS All meals on the ship are included in the cruise fare. Meals on the land tour are not included; however a plan can be purchased for the IB5 tour for \$409 per person. (Includes Day 2 thru Day 5, Breakfast & Dinner and Day 6 Breakfast & Lunch on Direct-to-the Wilderness Train.)

CANCELLATION POLICY Once you secure your reservation, the following cruise cancellation fees apply. The cruise deposit if booked at the group rate is refundable up until March 24, 2020. All cancellation notices must be sent to the travel agency by email and receipt confirmed one day prior to the deadline.

If cancelled March 25, 2020 - April 26, 2020	10% of cruise total
If cancelled April 27, 2020 - May 24, 2020	50% of cruise total
If cancelled May 25, 2020 - June 7, 2020	75% of cruise total
If cancelled on or after June 8, 2020	100% penalty - No Refund

PRINCESS VACATION PROTECTION PLAN With the Princess Vacation Protection plan if you need to cancel for some of the most common reasons (severe weather, illness, etc.) you will get 100% of the cost of your trip back, in cash. If you need to cancel for any reason not covered by the plan, the standard plan gives you 75% back in the form of a future cruise credit certificate. The platinum plan gives you 100% back in the form of a future cruise credit certificate. For the plan description go to <http://www.princess.com>. The standard plan premium is 8% of the trip cost. The platinum plan premium is 12% of the trip cost.

TRAVEL INSURANCE - Independent plans that cover unforeseen circumstances are also available with Travel Guard. The premium is based on the passengers age and trip cost. If purchases within 15 days of initial trip payment it includes a waiver of pre-existing medical conditions. A group plan is available with Roam Right with a minimum of 10 passengers. The premium is based on 6.14% of the trip cost and the plan is secondary to other coverages. Both plans offer trip cancellation, trip interruption and medical reimbursement coverage.

GRATUITIES A \$14.50 per person per day gratuity (for inside, ocean view or balcony staterooms) or \$15.50 per person per day (for mini-suites) and will be automatically added to each guest's onboard account on a daily basis. Guests who prepaid gratuities prior to boarding their cruise will not see a daily charge onboard. A 15% gratuity is also automatically added to beverages, mini bar, spa & salon purchases.

AIRFARE The airfare prices will vary depending on your departure city. Airfare is non-refundable and non-transferable. Flex air booked through the cruise line is flexible and payment is not required until the cruise final payment date.

GROUND TRANSPORTATION The cruise line provides ground transportation from the Fairbanks airport to the hotel for \$14 per person. Arrive in Fairbanks anytime; hotel check-in is 4:00 pm. In Vancouver the transfer is \$29 per person and flights on July 4th should depart after 11:00 am.

PRE & POST CRUISE HOTEL STAY Additional hotels nights are available in Fairbanks for a pre-tour stay and Vancouver for a post-cruise hotel stay
